Other notes:

- **IKON PASS HOLDERS:** This ticket cannot be removed from the package price. Credit of \$372 from package price in this amount will be provided to the person for use at Snowbird owned restaurants, shops, facilities. Credit is not convertible to cash.
- If you want to :
 - Single Room: Take an entire hotel room to yourself then **add \$999**

- **Option to ski at Alta:** Alta connects to the mountain at Snowbird and you are encouraged to upgrade this lift ticket so you can enjoy the best of both mountains. Official prices haven't come in yet for the Alta lift ticket but expected to be around **\$175** extra for five days. Exact pricing should be available around July.

Payments/requirements: (can make payments on our BRSOC website- 3% fee)

- You **must** be a current member of the BRSOC **when you sign up** for this trip. Membership is \$18/person or \$30/family. Application is attached if you haven't rejoined.
- You **must** fill out trip application for each person going.
- **\$400** non-refundable security deposit is due no later than **May 15, 2020**. **(DUE NOW if you want to guarantee your flight out of Greensboro at the pricing we have now. **See extra note below about refund rules****
 - Pay Schedule if your total cost is \$2002.
 - \$400 by May 15;\$250 by July 1;\$250 by Aug 1;\$250 by Sept 1;\$250 by Oct 1;\$250 by Nov 1;\$96 Paid in full by Dec 1. **Or you can pay in larger amounts or all at once, I will work with you.** As long as the minimum amount paid monthly is kept up to date.
 - Pay Schedule if your GROUND ONLY total cost is \$1642.
 - \$400 by May 15;\$200 by July 1;\$200 by Aug 1;\$200 by Sept 1;\$200 by Oct 1;\$200 by Nov 1;\$36 Paid in full by Dec 1. **Or you can pay in larger amounts or all at once, I will work with you.** As long as the minimum amount paid monthly is kept up to date.
